Encouraging and enabling residents to contribute to their own care plan.</li> <li>3. Providing as tactfully as possible human or technical assistance when it is needed</li> <li>4. However, they can be reviewed more frequently if a change of circumstances or an on-going or developing problem arises. Residents, their family and friends, health professionals and Social Services are encouraged to become involved in the preparation of care plans.</p>
