We have tried locally through adverts and social media but with no response. All 6 are qualified nurses from their home countries but 5 was unsuccessful with the English exam so they have been hired as carers until they can pass their exams. I have one that is now a qualified nurse who has gone through different exams and has a pin number.

All individuals at Plas Derwen lack capacity at varying degrees, choice is given to individuals at levels personal to them, which may be what they would like to wear, eat or drink. One individual chose not to move rooms. All individuals have personalised care plans which reflect what choices they are able to make. Relatives and friends are consulted on past likes and dislikes, (although these do change with dementia). Applications are made for deprivation of liberties when consent can't be given. Best Interest meetings/discussions are held when choices by the individual are limited.
The extent to which people are happy and supported to maintain their ongoing health, development and overall wellbeing. For children, this will also include intellectual, social and behavioural development.	There is an individualised program of activities which is tailored to each individual's likes, staff promote interactions in each individual's timeline, promoting happy and healthy engagement. Positive risk taking is encouraged, baking, going out to the community. All individuals have access to GP, DENTIST, FOOT CARE PROFESSIONAL and specialist services when necessary. Escorted hospital appointments.

Training in mandatory training and specialist training in dementia medication, catheter, phlebotomy and other specialist area. Reporting of incidences through Safeguarding. Health and Safety checks as per legislation. Positive culture towards individuals from all levels and staff disciplines. Monthly/3 monthly audits of medication, food hygiene, house-keeping, infection control. Regular supervisions. Monthly meetings with staff and management. Checking over of care plans and complaints by RI.
