Summary

Children are very happy and have formed warm relationships with staff and each other. They enjoy their time at the service and are confident to let staff know what they want. Children have an excellent range of experiences and have plenty of opportunities to choose.

Staff know how to keep children safe and healthy. They support individual children in a warm and highly positive manner. They are kind and friendly and exceptionally calm. Staff plan a range of activities that are exceptionally interesting which help children to learn and develop their skills. Staff thoughtfully plan activities in line with children's interests.

People who run the service provide a safe and comfortable environment for children with exceptional learning opportunities and ensure hazards and risks are monitored and managed effectively. They provide a range of outstanding natural resources and experiences for children to help themselves to which are highly effective developing their social, physical and creative skills and provide exceptional learning opportunities.

People who run the service manage the provision very well and understand their regulatory responsibilities. Documents and suitability checks are kept up to date and parents are kept well informed about their children's development. There are highly successful partnerships with the school and local community.

Well-being**Good**

Children are happy and settled. They move around the natural resources and activities freely and can choose for themselves as everything is stored within their reach. They are happy to follow their own interests and to show what they want. For example, by pointing to a football and taking it outside. Children can choose whether to play inside or outside.

Children have formed warm relationships with staff and each other. They feel secure and are confident, for example, some were confident speakers telling us about siblings in the school and others took our hand to show us what they were doing with Pudsey bear. Children are happy to approach staff for comfort, and are provided with positive words of encouragement and help to sort a disagreement when needed.

Most children share resources and play alongside each other well. They happily chat to the staff about what they are doing and are eager to involve them in their play. For example, when looking for shapes in the sensory tray they chatted to staff about what they had found. They also enjoy spending quieter times relaxing on the comfy chairs or lying on the rug in front of the fire. Children have freedom to join activities or choose something different.

Children have an excellent range of experiences and are able to choose to spend time outdoors. They use the small garden daily along with the school yard and field. They have good opportunities to develop physically and socially as they can meet up with siblings from school. Children are encouraged to do things for themselves, such as helping to put resources away and putting on their own coats. This helps them to gain confidence and promotes their independence.

Care and Development

Good

Staff understand their responsibilities to keep children safe and healthy. Several staff members also work in school so they are very familiar with the correct procedures to follow should there be any concerns about a child. Documentation records accidents and parents are made aware. Staff ensure regular safety checks are undertaken and fire drills are completed with the school.

Staff promote a healthy way of life by providing children with snacks and the option of a school lunch which they eat in the hall alongside their brothers and sisters. However the snacks provided are not always the best healthy options. Staff ensure children wash their hands, such as after using the toilet and before eating, promoting good hygiene.

Staff have built highly positive relationships with the children. They are kind and friendly and deal with any unwanted behaviour exceptionally calmly and fairly. They use positive ways to support individual children if they begin to show any difficulties with sharing. For example, by clearly and simply explaining how sharing works and showing younger children how to include a friend. If this does not work then by providing children with a duplicate resource is usually successful.

Staff plan a range of activities that are exceptionally interesting such as threading lemon slices onto sticks which help children to learn and develop their skills. Staff thoughtfully plan activities in line with children's interests or a theme such as Children in need. Planning and observations were being reviewed to create a more streamlined and more effective record. Staff keep parents well informed, ensuring they are kept up to date with their child's progress and important information about their time at the setting.

Environment**Excellent**

People who run the service provide a clean and safe environment for children. A small exciting garden has been developed outside the room, and children can move freely between indoors or outdoors to play. Risk assessments are in place outlining any potential hazards to children including the fire and the measures put in place to manage these.

People who run the service ensure they provide an excellent range of resources for children to choose from outdoors including re cycled, natural and life size equipment such as brass jugs for water play. The large outdoor play area offers plenty of space for children to play and explore and meet older siblings and friends to share ball games and develop their physical skills. Indoors there is an outstanding range of natural and interesting resources such as sand in a large suitcase, real fruit and vegetables displayed in hessian covered boxes for children to explore and enjoy sensory experiences as well as using them to discover exciting shapes for printing.

People who run the service have a range of inspiring ways to help younger children's independence skills. For example, aprons are hung on a wooden oar for children to easily access and put on themselves. All items are exceptionally well organised and kept safely in wooden boxes and individually styled crates stored at low level so children can reach equipment independently and develop their play.

Leadership and Management**Excellent**

People who run the service have a sound understanding of their role and regulatory responsibilities and provides a range of clear and informative policies to enable the service to run safely and effectively. The statement of purpose reflects the service offered, providing parents with plenty of information to make an informed choice. The documentation also reflects procedures put in place during the Covid-19 pandemic, keeping parents up to date with changes.

People who run the service have a very clear and inspiring vision of how they want the service to be. They actively seek feedback and innovative and exciting changes and new ideas which improve outcomes for the children.

All disclosure and Barring Service (DBS) check are valid and up to date. Records provided showed all information about the children prior to them attending had been sought. This allows to plan effectively to meet children's individual needs. Staff work together well and regularly discuss planning and how to improve learning outcomes for the children.

There is an excellent partnership with the school with whom the service shares resources such as the outdoor area and the school hall for lunch. The service is an integral part of the school and staff are available to help if needed. Some staff also work in the school and this strengthens the relationship between the two services and makes transition for the younger children exceptionally easy. There is a good relationship with the community and recently the children joined in a local event by making a scarecrow as part of a competition. This creation features part of a horse and rider jumping the school hedge and is a talking point in the village.

R1 To consider the nutritional guidance for early years settings to ensure all snack options are healthy.

R2 To continue to develop assessment and planning documentation.
