Summary

This was a focused inspection, and, on this occasion, we only considered the themes of well-being, care and development, and leadership and management.

Children are happy, settled and enjoy their time at the setting. They have sufficient play and learning opportunities to choose from. Children of all ages enjoy socialising with their friends and engaging in the opportunities that are on offer to them.

Staff are appropriately qualified and implement procedures to keep children safe and healthy. They are kind and caring towards the children and support their development.

Leadership and management of the setting is improving. Priority areas have been addressed since the last inspection, and safe closing procedures have been embedded, and leaders ensure that staff are appropriately trained. The management structure has stabilised and the person in charge (PiC) is supported by a very competent deputy manager. The management team play a vital role in the day to day running of the nursery to help create better outcomes for children.

Well-being

As this was a focused inspection, we have not considered this theme in full.

Children predominantly make their own decisions about how they spend their time at the setting and can choose between self-directed or adult led activities. For example, children play in the home corner or take part in arts and crafts activities. Children's interests help staff structure adult led activities, for example, children were asked what songs they wanted to sing or what stories they would like to listen to.

Children are happy, safe, and valued. They are developing friendships in line with their age and stage of development. Children are making good attachments with the staff who care for them. For example, an unsettled child accepted cuddles from a member of staff and other children invite staff into their play. Lots of the children's work is displayed throughout the nursery, which helps children feel valued and celebrated.

Children enjoy the opportunities for learning and play. Children engaged very well, having chosen large construction blocks to build a tower. They co-operated well with their friends trying to build towers as high as themselves.

Children have opportunities to develop their independence skills. Staff encourage older children to use the toilet and wash their hands themselves. We saw children eating breakfast independently, having chosen their bowl and cereal and poured their milk. Some opportunities at gaining skills were lost within the toddler room. Toddlers are unable to attempt to hang their coats as there are no coat hooks and so use a communal box to store their bags and coats.

Care and Development

As this was a focused inspection, we have not considered this theme in full.

However, staff have received appropriate training and implement procedures to keep children safe and healthy. They maintain accurate registers and supervise children appropriately. Their interactions with children are warm and nurturing.

Leadership and Management

As this was a focused inspection, we have not considered this theme in full.

Leadership and management of the setting is improving. Leaders have ensured that the Priority Action Notices issued at the last inspection have been addressed fully. They have reviewed safe closing procedures and updated all staff on these procedures to ensure registers are completed accurately and promptly. Leaders continue to review risk assessments and have submitted notifications to Care Inspectorate Wales as needed.

Staffi are appropriately qualified, and ratios are maintained in line with regulations in each childcare room. An identified person in charge is always present at the nursery. All staff have received updated training regarding food hygiene, safeguarding and all staff hold a paediatric first aid certificate. Monitoring of the service has improved and both the person in charge and her deputy are motivated to continue to develop the service. We discussed resources within the toddler room and were told that this has been identified by leaders as an area needing improvement.

Recommendations from the previous inspection were not fully tested and remain in place for leaders attention.
