#### Summary

This was a focused inspection, and, on this occasion, we did not consider all themes in full.

Children are happy and settled at the setting. They have opportunities to follow their interests. They know staff listen to their needs and wants. Children gain a sense of belonging at the setting by seeing their artwork and photographs displayed around the room.

Staff are professional and enjoy their work. They are kind and caring and interact well with children. They have a sound understanding of how to keep children safe and healthy. Staff and leaders keep good records of safety checks and procedures.

Leadership and management of the service is sound. The management team support staff to carry out their jobs well.

#### Well-being

As this was a focused inspection, we have not considered this theme, in full.

Children have a good range of opportunities available to them and can choose where and how they spend their time at the setting. They move around the setting freely choosing from the activities and resources available to them and can access both indoor and outdoor areas throughout the day. Children express themselves well and confidently communicate their needs. For example, a child requested a basket of toys which was provided by staff.

Children are settled and happy. Those who are new to the setting receive the support and care they need ensuring they settle quickly. Children know the staff well, so they feel relaxed in their care. They form positive friendships that help them feel happy. For example, a group of children enjoyed setting up the role play area, pretending to serve each other at the kitchen table whilst chatting.

Children cooperate well and enjoy sharing the play space and resources. They learn to have respect for each other and the items they play with. We saw children take turns whilst playing on the indoor climbing frame, waiting at the top and counting before sliding down after their friends.

Children show enjoyment as they play and choose activities. For example, children laugh and jump up and down whilst playing a game on the floor mats. Children have increased opportunities to follow their interests and extend their learning through their play. Opportunities for quiet time are available if children require. We saw a child sit on the cushions, quietly observing others whilst playing a keyboard.

Children have opportunities to develop their skills and be independent. Older children freely access the toilet and handwashing facilities themselves. Younger children are given support when needed. Children were encouraged by staff to sing 'this is the way we wash our hands' whilst washing their muddy hands after outdoor play.

#### **Care and Development**

As this was a focused inspection, we have not considered this theme, in full.

Staff have a good understanding of their roles and responsibilities within the nursery. They follow procedures to ensure children's safety is paramount. Staff we spoke to were confident in their role in keeping children safe. Incidents are recorded appropriately. The kitchen area is clean, and children do not have access to this area. Staff ensure that unpermitted areas to children are closed off with baby gates or number locked doors. They also ensure that the electric cooker is switched off at the main power point on the wall which is out of reach to children. Staff carry out regular fire drills to ensure children and staff know the appropriate action to take should a real evacuation be necessary. They regularly update risk assessments for the nursery and equipment which are thorough. Staff check areas highlighted within the fire risk assessment are checked weekly including fire alarm testing, fire doors and fire escape routes checked. They have been trained in fire safety, fire extinguisher use and as fire marshals. This ensures staff know how to react to a fire situation within the setting to ensure children's and their own safety.

Staff work well together to support and promote children's social behaviour, taking into consideration their age and stage of development. For example, a member of staff in the baby room, recognised that a child was upset because they wanted their lunch. They are positive role models to the children in their care, treating them and each other with care, respect and kindness.

Staff are supportive, nurturing and engage positively with children to support their play and development. Next steps in children's learning are displayed around the childcare rooms to ensure all staff are aware of every child's development stage.

#### **Leadership and Management**

As this was a focused inspection, we have not considered this theme, in full.

Leadership and management of the service is good. The Responsible Persons (RP) are supportive to their staff team. Staff told us they value the support they receive from the management team. Leaders take advice from outside agencies to make decisions regarding staffing and if needed, disciplinary procedures.

During the inspection while looking through paperwork, we noticed that two incidents had occurred at the nursery that Care Inspectorate Wales (CIW) had not been made aware of. However, during the course of the inspection, leaders have notified us of these incidents. We will not be taking any action with regards to this.
